UNITED STATES DEPARTMENT OF AGRICULTURE (USDA) DEFINITION OF ORGANIC

Organic is a labeling term found on products that have been produced using cultural, biological, and mechanical practices that support the cycling of on-farm resources, promote ecological balance, and conserve biodiversity.

#### ORGANIC STANDARDS

To be organically certified, farms must be verified by a USDA-accredited certifying agent. Regulations include the following:

TIMELINE OF ORGANIC REGULATION IN THE U.S.

#### 1973

Oregon passed the first state law regulating organic food.

## 1990

Congress passed the Organic Food Protection Act (OFPA) that established marketing and production standards and facilitated interstate commerce of organically produced fresh and processed food.

#### 1992

USDA established National Organic Program (NOP) and appoints National Organic Standards Board (NOSB).

### 2002

National Organic Standards become law after years of development.
